All applications **must be received** by January 20, 2009. Any invalid application forms, invalid or unacceptable payment, or application forms received after January 20, 2009 will be returned.

Dealer's Den Rules:

1. Hours of Operation:
Friday – 11am to 6pm
Saturday – 10am to 6pm
Sunday – 10am to 4pm
2. Cancellations and Refunds: Full refunds will be available provided notice is given prior to December 20th, 2008. Any notices tendered between December 20th, 2008 and January 20th, 2009 will be granted a 50% refund. **There will be no refunds after January 20th.** Please plan accordingly, and inform us as soon as possible of any cancellations.
3. Dealers are allowed access to the Den 1 hour prior to opening and 1 hour after closing, with the exception of Set-Up and Tear Down. Dealers may access the Den starting 9am Friday morning for Set Up, and must completely vacate the room by 6pm Sunday evening. For any additional access, contact the Dealer's Den Head. Registration and badges will be available for pre-registered Dealers at the Dealer's Den Administration Table in the Den starting 9am Friday morning. To have your pre-registered Helper's registration and badge also available, please contact the Dealer's Den Head by February 13, 2009. All other Helpers or non-preregistered Dealers must obtain their registration packet and badges from the normal registration lines.
4. Dealers are responsible, within reason, for housekeeping in the area around their table, including during Tear Down. Please be sure to tidy your area at the end of each day.
5. One Helper and one Dealer are allowed per table. Dealers will be furnished with a single Helper's badge which they may assign as they see fit. The Helper Badge does not act as a membership registration. The Helper Badge will be linked to the Dealer's ID, and the Dealer is responsible for all actions of the Helper. Helper Badges will be available when the Dealer checks into the Den Friday morning. Dealers may submit a custom graphic/text for their Helper Badge up to February 13, 2009. Please submit the graphic to dealers@furryfiesta.org in digital format.
6. All Adult Material (including written, video and physical) must be censored. The Dealer is responsible for policing his or her own table, to keep minors from being inadvertently exposed. All minors will be wearing a Minors badge, clearly marked, but Dealers must ID if the individual appears to be less than 18 years of age.
7. Any material 'Shipped Ahead' must have permission by the Dealer's Den Head, in writing, prior to shipping. DRAMA assumes no liability for items lost in shipping, or for any items shipped without adequate arrangement.
8. Dealers must collect all Taxes and Tariffs required by the State of Texas and the City of Addison. Dealers are responsible for the submission of these fees to the appropriate offices.
9. With the listed exceptions, the following may not be sold:
 - a. Alcohol
 - b. Flammable/Incendiary items, with the exception of candles and incense
 - c. Firearms
 - d. Any and all items that violate either the laws of the State of Texas or the City of Addison.
10. Any wall hangings must comply with hotel regulations (see website for acceptable methods).
11. Dealers are responsible, within reason, for any damage to the equipment they are borrowing from the hotel. The borrowed equipment may not be modified in any way, including but not limited to: Holes, chips, paint, glue, and damage due to rough or inappropriate behavior. DRAMA is not liable for any damage to persons or equipment caused by the inappropriate use of hotel equipment, such as falling while standing on a chair or table. Please use provided equipment responsibly.
12. All rules listed for the Con as a whole must also be followed in addition to the rules listed here.
